I appreciate our approach to National Parks and AONB's is different in the UK - but what does a National Park vs SPA vs SSSI mean to most people - it feels like we don't have a clear approach to highlighting the importance and specialness of our unique wildlife sites. Forgive me for saying it - but my sense is that National Parks place landscape as a higher priority than wildlife, wildlife is more important in SPA's and SSSI's . That's very simplistic - but the general public might think National Parks are our special places for wildlife and don't know what the other designations are! It feels like an issue around brand, nudge behaviour, creating greater understanding of nature benefits to people and things we can do to benefit nature - and where. A Defra/NE piece of work to rebrand special places - think about how we might want different audiences to behave in different places.?? Is Morecambe Bay SPA special to most people - what does that mean - and how do most people know. What do SPA's mean nationally. How do we create a wider national sense of pride in our 'jewels' . Perhaps post research - post branding - a national TV/Social media/interpretation campaign - maybe with a long-term end-game (25 yrs from now?). to see a change in attitude. Where is the national investment to co-ordinate all the great stuff from conferences like this and turn it into a national story about the importance of our countryside , the wildlife within it and how to enjoy it positively.... sorry about my random ramblings.....

It is hard to tell - issues were rising in 2019 and have dropped significantly (Op Seabird launched in summer 2020) however we can't attribute that directly to Op Seabird (pandemic, fuel costs, weather etc. would have all had an impact) Anecdotally, I think it has raised more awareness and Jet Skiers tend to avoid the heavily visited, and therefore, 'watched' areas but it remains to be seen whether that trend continues in the long term

Has jet ski exclusion zones ever been considered during breeding season similar to no climbing on seacliffs during sea bird breeding times? Also have you had repeat offenders documented and have you considered legal action?

Yes, exclusion zones have been considered but enforcing them would need significant resources. We currently have a 'no wake zone' around the SPA which is voluntary but serves to raise awareness of the sensitivities and asks Jet Skiers to go slowly when close to the breeding site. We had repeated offenders in 2016 who were served with a 'stop notice' by Natural England under the SSSI legislation. They were prevented from using their Jet Skis within the SPA for 2 years. Other enforcement action has been taken by the Police and RSPCA for dolphin disturbance by boat last summer, in Scarborough.

For this reason, describing disturbance to dog owners can be tricky. Questionnaire results have shown that dog owners may have an awareness of disturbance but often think that other dog owners are causing harm, not themselves. Also believing that dipping into the heather off path, even only 1m in, causes no harm.

The United Nations Convention on Migratory Species convened a Scientific Task Force to advise on responses to HPAI in wild birds ([Scientific Task Force on Avian Influenza and Wild Birds HPAI winter 2021-2022 210122 final.pdf \(cms.int\)](#)) This recommends that human disturbance should be reduced around wetlands subject to a HPAI outbreak to minimise unnecessary flight among infected birds (using energy could inhibit their ability to fight the virus) and spread of the virus. The report also recommends that there is no benefit to be gained in attempting to control the virus in wild birds through culling or habitat destruction.

With Jet Skis, we had to find other methods - either those who we knew launched on the Yorkshire coast (through registering at council launch sites) or in-land lakes. When we first tried to engage with Jet Ski users, I think only about 2 users attended, at our last meeting we had about 20 users - we held an event at the in-land lake on a Saturday morning - when they would probably have been there anyway.
